Tremp City Council convened the 3rd Prize for Photography Landscapes of the Past, in accordance with the following:

RULES

1. PURPOSE

3rd Prize Photography Landscapes of the Past is announced to promote art and photography as an element of knowledge of the area and its geological wealth. We want to reflect the current creative moment of landscape photography, understood as the representation of the environment around us, both the nature and the impact that human activity can have. At the same time, we want focus on the natural, scenic and geological heritage of the Conca de Tremp through images.

2. ANNOUNCEMENT

The City Council of Tremp invited to attend all photographers over 18 years without any limitation on performance technique or editing photo files. Excluded are employees of the City Council of Tremp and the members and families of the jury. Each participant may submit up to two photographs, according to the procedure described in the point number 4 of these rules. Admission date will end on October 30th 2016 at 23:59 h.

3. CHARACTERISTICS OF THE WORK PRESENTED

- There are two categories: general and scientific.
- General Category: The theme of the work presented will focus on the idea of landscape photography and, specifically, should reflect the morphology of the landscape. The photographs must have been taken outdoor the territorial area of the Geopark Project Conca de Tremp-Montsec: the Pallars Jussà zone; and the territories of Baix Pallars (Pallars Sobirà); Coll de Nargó (Alt Urgell); Camarasa, Vilanova de Meià and Àger (Noguera). Photographs may be representational or abstract, color or black and white. You will have to identify the place from which the images were taken.
- Scientific Category: You must present images representing some scientific phenomenon connected with the earth sciences (geology, paleontology, hydrology, etc.).
- No photographs for its subject may offend any sensitivities or are offensive will be accepted.
- Photographs submitted for the contest must not have been awarded any other competition both domestically and internationally.
- Participating photographers are the owners guarantee that the material presented in the competition, who are owners of all intellectual property and have the appropriate authorizations in the case of people or places reflect private.
- The photograph may not be altered electronically or by any other way. Allow only minimal color correction and brightness. We will not accept collages. The photograph may not be framed or include any text. If in doubt, the organization can ask for file original photography raw or jpg. It will allow the framing of the original file.

4. PHASES AND SUBMISSION OF FILES

All photographs submitted for the contest must meet the requirements of all phases of selection, therefore, be rejected those that do not strictly meet these conditions or showing an obvious lack of quality for playback on the final phase of exposure.

The competition consists of three phases:

Preliminary stage:

- Only files in JPG format admit they did not exceed 1.2 MB .
- The files will be sent only through email platform www.wetransfer.com comunicacio@tremp.cat (specify details contestant: name, phone number, NIF , email address , postal address and date of birth) .
- Each file is named using the following structure: nombre_apellido_titulo.jpg
- The deadline for submission of files will be on October 30th 2016 at 23:59 h .

Selection phase:

- After passing the preliminary stage, the photographer should send selected files with Adobe RGB profile inlaid with a dimension on its longest side 60 inches and a minimum resolution of 180 pixels per inch, with a high quality JPEG format 12.
- Files are sent by means personally communicate the organization each author.
- Photographs which are not of acceptable quality for playback will be rejected and disqualified.

Exposure phase:

- To be selected up to 30 photographs will be reproduced with professional standards and supports conservation for exhibition about December of 2016.
- Completed the annual term of the award, the photographs reproduced and displayed may be returned to each author. The shipping and packing costs will be borne by each author, except the winning photographs will become part of the collection of the City of Tremp . The authors will be informed by the organization of the procedure for processing of returns.

5. JURY AND AWARDS

- The jury consists of renowned professionals related to the world of photography, art and geology. The composition of the jury can be found in the section of the municipal website.
- The jury will select two books and a second prize according to the following categories:
 - Award for Best Photography Landscape Past: valued at 1,200 euros
 - Award for best scientific photography: valued at 600 euros
 - Secondary prize: a lot of products Al teu gust, aliments Pallars
 - The finalists will receive a certificate.

Prizes are subject to withholding tax as determined by the current legislation.
